**1) Meeting Called to Order:**

Meeting called to order at 7:00 P.M.

**2) Roll Call & Verify Public Notice:**

Present: Supervisor Lee Weis, Supervisor Bruce Becker, Chairman Terry Schaller, and Supervisor Mitch Brohmer.

Excused: Supervisor Bob Wolfert

Also present were Fire Chief Nate Melby, Tony Curtis, Dennis Nelson, and Gary Simenson.

Pursuant to law, written notice of this meeting was given to the press, published in the La Crosse Tribune and posted on the public bulletin boards.

**3) Agenda:**

1. Public Hearing on the General Fund Proposed 2017 Budget and Utility District #1 Proposed 2017 Budget of the Town of Campbell, La Crosse County, will be held.

Clerk/Treasurer Chadwick Hawkins stated that with the levy limits in effect, the Town is able to raise the levy about one thousand, twenty three dollars from last year. Clerk Hawkins also stated that the Town lost one thousand, four hundred, and eighteen dollars due to annexations to the City of La Crosse.

The Board decided to wait roughly 15 minutes for any late arrivals before opening the floor for public comment.

*Tony Curtis, 600 Dauphin St.*, wanted to state he is happy seeing the roads being repaired this year and would like to see the process continue. Supervisor Becker stated he would like to have a possible referendum to see if the Town would be willing to continue repairing streets in the near future. Mr. Curtis also stated he would like the Town to have a plan in place to continue the progress of road repair. Supervisor Becker mentioned that the Town has already established a committee and has created a priority list of future road projects.

*Gary Simenson, 128 Locust St.*, asked why there is \$5000.00 allocated to the line item emergency management. Clerk Hawkins stated the line item has been in place for many years and used only for emergency purposes such as a flood or other natural disaster.

**Immediately following Public Hearing on the proposed budgets, a Special Town Electors Meeting will be held for the following purposes:**

1. To adopt the 2016 Town tax levy to be paid in 2017 pursuant to Section 60.10(1)(a) of Wisconsin Statutes.

Motion to adopt the 2016 Town tax levy to be paid in 2017 in the amount of \$1,155,137.42 made by Terry Schaller, seconded by Bruce Becker. **Motion Carried 4-0 (Melby, Curtis, & Simenson abstained)**

2. To approve the total year 2017 highway expenditures pursuant to Section 81.01(3) of Wisconsin Statutes.

Motion to approve \$762,119.41 for highway expenditures for 2017 made by Terry Schaller, seconded by Mitch Brohmer. **Motion carried 4-0 (Melby, Curtis, Nelson, & Simenson abstained)**
