### **THE CAMPBELL POLICE NEED YOUR HELP**

#### **Case Number 1: Criminal Damage to Property**

*The Campbell Police Department is seeking information regarding several instances of property damage by someone using a pellet gun or high powered B-B gun.*

*Property has been damaged in the 800 block of Kime Street, 3000 block of Howry Street and the 2600 block of Gerald Street.*

#### **Case Number 2: Stolen Vehicle**

*On 06-22-15, a 1998 Pontiac Grand Am Silver in color with Wisconsin License plates parked on private property in the 100 block of Walnut Street was stolen. Witnesses reported that a newer full size black Dodge pick-up truck hooked up to the car and removed it from the 100 block of Walnut Street. The truck was last observed heading east on Clinton Street into the City of La Crosse.*

#### **Case Number 3: Vandalism**

*During the weekend of July 24<sup>th</sup> – July 26<sup>th</sup> someone vandalized the Boat Launch Ticket Box at the West Spillway on French Island. #### **Case Number 4:**

*On 07-29-15 at about 8:54 PM, Campbell Police responded to a suspicious item on the Bainbridge Street pedestrian bridge. The item, a dark colored briefcase was placed on the south side of the bridge where the bridge starts to span the interstate. Due to the location of the item and its unusual location, the Dane County Bomb Squad was called to the scene. The item contained no explosives.*

#### **Case Number 5:**

*On June 23<sup>rd</sup> 2015, a female suspect entered a local grocery store and removed a package of fireworks from a store shelf, walked to the front of the store and tried to return them for cash. The clerk instructed the suspect she needed a receipt in order to get cash back. The suspect left with the fireworks.*

*A short time later the suspect returned with a male suspect. The male suspect attracted the clerk's attention away from the counter area. The female suspect then stole a clear plastic charity donation box off of the counter containing an unknown amount of money. Suspect left the store. Later that morning a Town of Campbell employee found part of the destroyed donation box nearby and turned it over to the police department.*



*The suspect has been identified as Tonnetta Fountain, Female, Black of La Crosse. The male suspect remains unidentified.
