3) Public Comment:

Motion to receive public comment made by Supervisor Becker, seconded by Supervisor Weis. **Motion carried 5-0**

Lee Donahue, 921 Plainview Rd., asked the Board to consider reestablishing the ice skating rink formally on Plainview Road. Mrs. Donahue mentioned that the Campbell Fire Department has offered to flood the rink if the Board moves forward.

Jo Ann Schaller, 2312 Bainbridge St., continued to express concerns about semis and trailers parking along Sky Harbour Drive and in the cul-du-sac at the end of Bainbridge St.

Andrew Jewel, 2830 Bayshore Dr., spoke to the Board regarding the issues he has with his neighbors and concerns with the current Chief of Police, Drew Gavrilos. Mr. Jewel read a lengthy statement to the Board. Chief Gavrilos gave his rebuttal to the Town Board.
