Tax payments can be made by mail, drop box, online or at the Town Hall.


Please make check payable to **Town of Campbell Treasurer**. Be sure to include your phone number on your check. If you'd like a receipt, enclose a self-addressed, stamped envelope. Tax payments must be made on a separate check from all other Town business payments.

### **Sewer Rate Increase**

Due to the City of La Crosse's wastewater treatment rates increasing over 62% from last year and planned capital improvement projects, it is necessary to increase the Town's sewer rates. Rates for 2023 will be \$407 per REU (Residential Equivalency Unit).

Renewals: Due January 1 each year

New Residents: License within 30 days

New adult dog/cat: License within 30 days

**Puppies/kittens**: License by 5 months of age

### **Animal Licensing**

All dogs and cats over 5 months old must be licensed. Renewal is due by January 1<sup>st</sup> with a grace period no later than March 31<sup>st</sup>.

Expired rabies information must be updated before a tag will be issued. It is the animal owner's responsibility to provide this information.

For new dogs/cats, you need to provide proof of rabies vaccination, dog/cat's name, breed, color, age/birthdate and

sex. Owners need to provide name, address, phone number, and driver's license number.

**Animal Fees:** 

Spayed/Neutered: **\$12** 

Unaltered: \$23

Payments can be made by mail or by drop box. Please include a phone number and enclose a self-addressed, stamped envelope so the tags can be mailed to you.

Please note that Town residents are limited to 2 dogs and 3 cats per household by Town Ordinance.
