**4) Discussion About the Town of Campbell Comprehensive Plan:**

There were numerous discussions about individual sections of the Town of Campbell Comprehensive Plan and the alignment with plans to incorporate into a Village. The consensus was that the essential elements are included on page 74 of the plan identifying the Five-Year Action Plan which includes:
