1) Call to Order:

The Board of Review was called to order at 4:09 P.M.

Clerk Fiksdal stated that the assessment roll was reviewed prior to open book which was held Monday, October 21, 2024 from 9:00 a.m. to 1:00 p.m. and assessment guides for property owners were available.

Mr. Hart indicated the affidavit attached to the assessment roll has been signed prior to the Board of Review.

B) Listen to Objecting Taxpayers Who Have Filed Written Objections for Real Estate or Personal Property Assessments.

Assessor Patrick Hart advised that no individuals had met with him to review their assessments during Open Book and did not wish to file a formal objection – all issues have been resolved prior.
